ON THE BASIS OF THOSE MOTIONS, THE DISTRICT COURT DENIED OUR CLAIM THAT THE CONSENT ORDER SHOULD BE RESTORED AND ENFORCED, BUT REFUSED TO DISMISS OUR CLAIM THAT THE DEFENDANTS SHOULD HAVE TO PAY THE PENALTIES THAT HAVE ACCRUED. THE CASE WAS SETTLED IN MARCH 2022 AND THE CASE WAS DISMISSED.
