THIS PROGRAM IS AN 8 MONTH DIRECT CASH TRANSFER PROGRAM WHERE PARTICIPANTS CAN RECEIVE UP TO \$500 PER MONTH FOR 8 MONTHS. PARTICIPANTS MUST ADHERE TO THE STRICT PROGRAM GUIDELINES TO RECEIVE THE PAYOUT EACH MONTH. THE PARTICIPANTS MUST BE PERMANENTLY HOUSED BY MONTH 4 AND SAVE A MINIMUM OF \$1,000 BY THE END OF THE PROGRAM.

THE HIGH WEEKLY RATES TO LIVE IN A MOTEL ROOM DOES NOT ALLOW FOR THE FAMILY TO SAVE ENOUGH MONEY FOR DEPOSIT AND FIRST MONTHS RENT TO BE ABLE TO MOVE FORWARD. THIS PROGRAM HELPS FAMILIES WITH SCHOOL AGED CHILDREN WITH DEPOSIT AND FIRST MONTHS RENT UP TO \$2,500 MOVE INTO AN APARTMENT OR RENT A SINGLE-FAMILY HOME.
