Dignity Grows is at the forefront of the response to the skyrocketing rate of Period Poverty through groundbreaking national research in partnership with top academic institutions, data-driven social policy change fostered by an extensive collaborative network, and national assemblies of powerhouse philanthropic, industry, and community change-makers. As the nonprofit leader in systemic change to end Period Poverty in the USA, the Dignity Grows model ensures direct hygiene support for tens of thousands of women and girls each year through the Hope in a Bag and Hope in a Backpack programs, powered by a collaborative, curated nexus of 60+ metro-area communities. Dignity Grows is the only national movement supplying menstrual hygiene necessities paired with comprehensive hygiene products for individuals and families to access in their own homes.

In 2023, Dignity Grows supported 51,500 underserved Americans with hygiene supplies and period products, all free to the end user. 40% of this support went directly to school-aged girls and their families. In 2023, Dignity Grows engaged 3,500 volunteers and partnered with 450 community organizations from metro areas across the US. In 2023, Dignity Grows powered the first-of-its-kind National Summit on Period Poverty. Representatives from 59 cross-sector agencies gathered at the LBJ Presidential Library in Austin, TX for change-making dialogue. In 2023, Dignity Grows launched the National Research Initiative on Period Poverty, which immediately yielded unprecedented data on the lived experience of Period Poverty in the US.
