Theinterested person shall not cast a vote on the transaction or arrangement involving thepossible conflict of interest.(ii) The chairperson(s) of the governing board or committee shall, if appropriate, appointa disinterested person or committee to investigate alternatives to the proposedtransaction or arrangement.(iii) After exercising due diligence, the governing board or committee shall determinewhether the corporation can obtain with reasonable efforts a more advantageoustransaction or arrangement from a person or entity that would not give rise to a conflictof interest.(iv) If a more advantageous transaction or arrangement is not reasonably possibleunder circumstances not producing a conflict of interest, then the disinterestedmembers of the governing board or committee shall determine whether the transactionor arrangement is in the corporations best interest, for its own benefit, and whether itis fair and reasonable. In conformity with the above determination, it shall make itsdecision as to whether to enter into the transaction or arrangement.(d) Violations of the Conflicts of Interest Policy.(i) If the governing board or committee has reasonable cause to believe a member hasfailed to disclose actual or possible conflicts of interest, it shall inform the member ofthe basis for such belief and afford the member an opportunity to explain the allegedfailure to disclose.(ii) If, after hearing the members response and after making further investigation aswarranted by the circumstances, the governing board or committee determines themember has failed to disclose an actual or possible conflict of interest, it shall takeappropriate disciplinary and corrective action.
