SOCIAL MEDIA COMPANIES ERODE BASIC HUMAN RIGHTS AND CIVIL LIBERTIES BY ENABLING THE SPREAD OF ONLINE HATE AND DISINFORMATION. THEY DENY THE PROBLEM, DEFLECT THE BLAME, AND DELAY TAKING RESPONSIBILITY.
