Ferndale Community Services operates 7 programs serving Ferndale and N Whatcom County. Our mission, to understand and alleviate unmet needs by providing support and resources to create a thriving community.

Bridge 2 Services connected unhoused individuals to needed resources to help them achieve self-identified goals. In 2023, we conducted over 150 outreach events and served 53 people in in-depth support, half of whom were youth.
