4b (Code: ) (Expenses \$ 435,325 including grants of \$ ) (Revenue \$ ) School Support - Served 626 students. We created and provided 114 literacy mentoring kits to 19 school sites. Our Read Fresno 1st graders grew an average of 60 points , while 1st graders as a whole grew an average of 40 points from initial to end of year testing. So our students grew 20 points more than the average student. We provided 4,445 meals to students during our Saturday Sports program during this year.
