FROM ENDING SLAVERY TO CIVIL RIGHTS TO WOMEN'S SUFFRAGE: SOCIAL MOVEMENTS HAVE ACHIEVED IMPOSSIBLE THINGS TO MAKE THE WORLD A BETTER PLACE.
