The Organization provided grant funding and support for the construction of 4 villages and renovations to an apartment complex to house Ukrainian families whose homes were destroyed due to the war. 518 housing units were completed in 2023 at these villages with more to be completed in 2024.

4b (Code:) (Expenses \$ 12,309,577 including grants of \$ 12,239,055) (Revenue \$)

The Organization built modular homes or provided grant funding for the building of homes for Ukranian families whose homes were destroyed. 371 modular homes were built for Ukrainian families so over 1,830 people were provided housing during the year. The materials are sourced in Ukraine whenever possible to provide jobs for Ukrainians to support the local economy. The construction of the homes provided 450 jobs to Ukrainians that lost work due to the war.

The Organization PROVIDED EMERGENCY AID TO CITIZENS OF UKRAINE SUFFERING FROM WAR in a variety of ways. The aid included sleeping bags, generators, food, safety equipment, and medical supplies and equipment to the people of Ukraine. In a Door Dash style, the Organization would deliver these to the elderly, disabled, and homebound when they were unable to get them. In 2023, the organization was able to make deliveries of medication and assist over 250 people in Chernihiv. Grocery deliveries were made to over 70 households women, children and handicapped individuals -- that could not obtain food due to the devastation of war in de-occupied villages of the Kharkiv Region. The Organization provided transportation in the form of rides or vehicles to individuals that lost vehicles or access to transportation due to the war. The Organization also helped transport people from the active war zones to safety in Western Ukraine. During the tax year, the Organization fed 7,300 people two hot meals a day.
