SUPPORTING CIVIL RIGHTS BASED LEGAL ACTIONS THAT SUPPORT, PROTECT AND UPHOLD WOMEN'S RIGHTS ON THE BASIS OF SEX AND TITLE IX. IN ADDITION, RESOURCES WERE USED TO EDUCATE THE PUBLIC THROUGH CONFERENCES, THE MEDIA, AND OTHER APPROACHES REGARDING THE RIGHTS OF WOMEN IN SPORTS, THE VALUE AND IMPORTANCE OF TITLE IX AS WRITTEN AND ITS PROTECTION, AND ACTIVE AND POTENTIAL LEGAL ACTIONS. TIME AND EFFORT HAS BEEN MADE TOWARD UNDERSTANDING HOW TO USE LEGAL PROTECTIONS AND TO DETERMINE THE MANNER OF FUTURE ENGAGEMENT WITH LEGAL CASES WITH ATHLETES IN VARIOUS SPORTS AND DISCUSSING THE BEST WAYS TO HOLD VARIOUS ENTITIES ACCOUNTABLE.
