ALL ANIMALS RECEIVE DAILY FOOD, WATER, MEDICATION, VACCINES, FLEA PREVENTATIVE, ENRICHMENT ACTIVITY, DRY AND CLEAN SHELTER AND, IF NEEDED, HUMANE EUTHANASIA.
