LAW & POLICY - AS AN ON-THE-WATER ADVOCACY ORGANIZATION, PUGET SOUNDKEEPER WORKS TO DIRECTLY ENFORCE THE CLEAN WATER ACT THROUGH ACTIONS RANGING FROM WATER QUALITY MONITORING AND LEGISLATIVE AND ADMINISTRATIVE ADVOCACY TO TAKING POLLUTERS TO COURT AND ENFORCING THE LAW. TO DATE, OVER 200 LEGAL ACTIONS HAVE BEEN FILED THROUGH THIS PROGRAM AND MILLIONS OF DOLLARS HAVE BEEN SPENT BY POLLUTERS TO CLEAN UP THEIR FACILITIES AND RESTORE THE COMMUNITIES AND ECOSYSTEMS DEGRADED BY THEIR ACTIVITIES.
