THE CAMPAIGN EDUCATES THE COMMUNITY AT EVENTS, SEMINARS HELD AT LAW FIRMS AND BAR ASSOCIATION MEETINGS, AND THROUGH NEWSLETTERS AND PUBLICATIONS. THE FOCUS IS ON THE BARRIERS LOW-INCOME OREGONIANS FACE IN ACCESSING LEGAL HELP WHEN FACED WITH CIVIL LEGAL PROBLEMS.
