FRIENDS OF THE RIVER'S (FOR) PROGRAM WORK SEEKS TO PROTECT AND RESTORE CALIFORNIA RIVERS THROUGH HYDROPOWER REFORM, RESTORING FLOWS, ADVOCATING FOR SUSTAINABLE WATER STORAGE, FLOOD MANAGEMENT, LEGAL PROTECTION, AND PUBLIC ENGAGEMENT. IN 2023, THE ORGANIZATIONAL PROGRAM WORK FOCUSED ON THE FOLLOWING AREAS: PROTECTING RIVERS FROM COSTLY AND ENVIRONMENTALLY DESTRUCTIVE DAMS, RESERVOIRS, AND DIVERSIONS. FRIENDS OF THE RIVER CONTINUED TO LEAD A COALITION OF CONSERVATION ORGANIZATIONS' RESPONSE TO PROPOSED SURFACE WATER RESERVOIR PROJECTS. A CRITICAL PART OF THAT WORK INCLUDES MANAGING THE STORAGE RESPONSE GROUP (SRG), WHICH IS A MULTI-STAKEHOLDER COALITION THAT WORKS ON RESERVOIR PROJECTS. FRIENDS OF THE RIVER LED COORDINATION OF A COALITION OF ENVIRONMENTAL NON-PROFIT ORGANIZATIONS AND CALIFORNIA TRIBES IN THE SITES RESERVOIR WATER RIGHTS PROCEEDINGS. OTHER NOTABLE PROJECTS INCLUDE THE PROPOSED DEL PUERTO CANYON DAM, AND THE SHASTA DAM RAISE. FRIENDS OF THE RIVER ORGANIZED ALLIED ORGANIZATIONS, ENGAGED IN CONSTRUCTIVE COMMENTING AND FEEDBACK TO THE ACCOUNTABLE REGULATORY AGENCIES, AND GENERATED EARNED MEDIA TO EDUCATE THE PUBLIC. FOR ALSO SUBMITTED FORMAL WATER RIGHTS PROTESTS FOR THE PROPOSED DELTA TUNNEL, WHICH WOULD FACILITATE MORE WATER EXPORTS FROM THE CRASHING DELTA ECOSYSTEM. PROMOTING HYDROPOWER POLICY AND OPERATIONAL REFORM. DAMS WITH HYDROPOWER PROJECTS CAN HAVE A TREMENDOUS NEGATIVE ENVIRONMENTAL IMPACT ON RIVERS. THESE HYDROPOWER PROJECTS ARE RELICENSED ONCE A GENERATION, EVERY 30 TO 50 YEARS. FRIENDS OF THE RIVER WORKED ON A NUMBER OF RELEVANT HYDROPOWER AND PUMPED STORAGE HYDROPOWER PROJECT RELICENSING PROCEEDINGS, AS WELL AS HYDROPOWER POLICY AND LEGAL ISSUES TO PROTECT, ENHANCE, AND RESTORE CALIFORNIA'S RIVERS, WATERSHEDS, AND COMMUNITIES AFFECTED BY HYDROPOWER OPERATIONS. MUCH OF THE WORK IN 2023 WAS DEDICATED TO TRACKING AND CONTRIBUTING TO THE RESPONSE TO THE INTENSIFYING CLEAN WATER ACT SECTION 401 WAIVER ISSUE THROUGHOUT CALIFORNIA, INCLUDING CONTINUING LITIGATION CHALLENGING THE FEDERAL ENERGY REGULATORY COMMISSION'S WAIVER OF SECTION 401 ON HYDROPOWER PROJECTS IN THE YUBA AND MERCED RIVER WATERSHEDS. FRIENDS OF THE RIVER ALSO PROVIDED LEADERSHIP ON PRIORITY PROJECTS SUCH AS OROVILLE DAM OPERATIONS AND FLOOD SAFETY ON THE FEATHER RIVER AND NARROWS 1 ON THE YUBA RIVER. PROMOTING SUSTAINABLE WATER SOLUTIONS FOR CLIMATE CHANGE. HEALTHY RIVERS ARE CRITICAL FOR CLIMATE RESILIENCE. CLIMATE CHANGE IS BRINGING INCREASED DROUGHT AND FLOOD TO CALIFORNIA. HEALTHY RIVERS, WITH NATURE-BASED MULTI-BENEFIT FLOOD PLAINS CAN PROVIDE BENEFITS FOR BOTH DROUGHT AND FLOOD, BY STORING FLOOD WATERS AND RECHARGING GROUNDWATER. NATURAL RIVER FLOWS SUPPORT THE MOVEMENT OF PLANTS AND ANIMALS UP AND DOWN THE WATERSHED, PROVIDING RELIEF FROM DROUGHT, FLOOD, DISEASE, AND INVASIVE SPECIES, AS WELL AS PROMOTING A RIPARIAN ENVIRONMENT TO PROVIDE REFUGE FROM EXTREME HEAT AND COMBAT WILDFIRE RISK. FOR DEVOTES SIGNIFICANT TIME AND EFFORT TO (1) EDUCATING THE PUBLIC ABOUT THE IMPORTANCE OF HEALTHY RIVERS, (2) POLICY ANALYSIS, AND (3) ENGAGING IN CONSTRUCTIVE PUBLIC COMMENTING TO RESTORE ENVIRONMENTAL FLOWS TO CALIFORNIA RIVERS. WINTER 2023 WAS UNUSUALLY WET FOR CALIFORNIA, SO FOR FOCUSED SOME OF ITS COMMUNICATION AND EDUCATION EFFORTS ON THE IMPORTANCE OF NATURE-BASED FLOOD MANAGEMENT AND GIVING RIVERS ROOM. FOR ALSO INFORMED THE PUBLIC ABOUT DRY RIVERS LIKE THE SCOTT AND SHASTA RIVERS. BUILDING PUBLIC SUPPORT FOR RIVERS. FRIENDS OF THE RIVER CONNECTS PEOPLE TO RIVERS THROUGH OUR RAFTING AND CANOE PROGRAMS. THESE PROGRAMS WERE DRASTICALLY REDUCED DUE TO SAFETY CONCERNS FROM THE COVID-19 PANDEMIC. IN LATE 2022, FOR BEGAN TO REBUILD ITS RAFTING PROGRAM. IN 2023, FOR HOSTED A GUIDE-ACTIVIST TRAINING, IN WHICH PARTICIPANTS LEARNED TO GUIDE WHITEWATER RAFTS AS WELL AS RIVER ACTIVISM SKILLS. THE TRAINING IS INTENDED TO BUILD THE NEXT GENERATION OF RIVER ADVOCATES. FOR PROVIDED DEI SCHOLARSHIPS TO REMOVE BARRIERS FOR SOME PARTICIPANTS. ADDITIONALLY, FOR HOSTED RIVER TRIPS TO SUPPORT LOCAL NATIVE TRIBES IN RECONNECTING TRIBAL MEMBERS AND YOUTH TO THEIR ANCESTRAL WATERS. FOR ALSO HOSTED TRIPS FOR OTHER NONPROFIT ORGANIZATIONS TO FURTHER REDUCE BARRIERS TO OUTDOOR RIVER RECREATION.
