IN ADDITION, EVERYONE WHO SIGNS THE ANNUAL COI ATTESTATION WILL LIST THEIR POSSIBLE CONFLICTS. THE CHAIR OF THE BOARD, SECRETARY OF THE BOARD, AND UPWARDLY GLOBAL'S CEO WILL RECEIVE THE LIST(S). ALL WILL BE TASKED WITH ENSURING THE CONFLICTED PARTY IS EXCLUDED FROM TRANSACTIONS THAT WOULD BE AFFECTED BY THE RELATIONSHIP.
