WE STRENGTHEN THE AFRICAN VOICE IN GLOBAL DEVELOPMENT DISCOURSE BY DRAWING ON THE ANALYSES AND EXPERIENCES WORKING WITH DECISION-MAKERS IN AFRICA TO INFORM THE INTERNATIONAL DEVELOPMENT COMMUNITY'S INVESTMENT POLICIES IN AFRICA.
