A total of 76 youth ages 8-18 participated within YES's Youth Leadership Pathway programs. Youth ages 8-13 learned about their responsibility to the natural environment through regular outdoor and camping trips. Youth visited locations such as Point Reyes National Seashore and the East Bay Regional Park District, learning about diverse wildlife and ecosystems. Teens ages 14-18 continued an ongoing park enhancement project at Nicholl Park, and they organized awareness campaigns to prevent pet waste pollution from entering San Pablo Creek Watershed. Their efforts helped to protect and preserve local outdoor spaces, ensuring that Richmond youth and families are able to access the benefits of nature for years to come.

YES continued to build strong partnerships with local schools through the Richmond Outdoors Coalition (ROC), of which YES is the backbone agency and fiscal sponsor. After a 12-month planning process alongside West Contra Costa Unified School District and nine non-profit partners, the ROC initiated a three-year pilot program in two elementary schools, one middle school, and one high school this past school year. Through this partnership, YES has collaborated with WCCUSD teachers, administrators, and counselors to engage students and their families in multiple, repeated, and reinforcing outdoor experiences all year. In the 2023-24 school year, 1,049 students and their family members participated in ROC programs, logging an average of five outdoor experiences per person. Additionally, students attended 59 off-site field trips to local, regional, state, and national parks.

Adult programs support adults aged 18 and older in developing into civic minded community members. 26 adults program in 2024. Adult programs support adults in developing and harnessing their strengths and passions to achieve their personal goals and grow as leaders. Participants gain leadership skills, individualized mentoring, and engage in community-based action projects. In recent years, 65% of adult alumni have gone on to hold leadership positions, such as on school boards and civic committees, driving forward community-led decision-making.
