SINCE 1982, CBA HAS DEVELOPED 556 RESIDENTIAL UNITS HOUSING MORE THAN 1,100 PEOPLE AND CONSISTING OF 18 DIFFERENT BUILDINGS/SITES IN LOWELL, HAVERHILL, AND DRACUT. SINCE 1982, CBA HAS INVESTED MORE THAN \$189 MILLION IN DEVELOPING STABLE NEIGHBORHOODS IN THESE COMMUNITIES. CBA ALSO PROVIDES COMPLETE THANKSGIVING TURKEY DINNERS TO ACRE RESIDENTS, WITH PLANS TO DISTRIBUTE 350 EACH NOVEMBER.
