EDUCATION AND CAREER ADVANCEMENT SERVICES: OUR INSTRUCTORS EMPOWER IMMIGRANTS WORKING TO BUILD FINANCIALLY STABLE, PRODUCTIVE LIVES SO THEY MAY BREAK THEIR CYCLE OF POVERTY FOR THEMSELVES AND THEIR CHILDREN. THE RIAN IMMIGRANT CENTER IS THE FISCAL SPONSOR OF THE MIC. IMMIGRANTS ARE THE BACKBONE OF SUPPORT FOR THE CITY OF BOSTON AND ITS SURROUNDING COMMUNITIES. MANY IMMIGRANTS WERE STRUCK BY LOSING THEIR JOBS AND HAVING LITTLE TO NO ACCESS TO BENEFITS OR HEALTHCARE. THE FOCUS OF MIC'S PARTNER ORGANIZATIONS IMMEDIATELY SHIFTED TO MEET THE NEEDS OF ITS DIVERSE COMMUNITIES. THE PURPOSE OF THE COLLABORATION IS TO ADDRESS IMMIGRANT FAMILIES' MOST URGENT NEEDS BY PROVIDING DIRECT FINANCIAL RELIEF AND OTHER RESOURCES. JOINING FORCES HAS ALLOWED MIC TO SERVE MORE THAN 59,000 INDIVIDUALS ACROSS MASSACHUSETTS SINCE APRIL 13, 2020.
