826 Valencia is a San Francisco-based nonprofit organization dedicated to supporting students ages 6 to 18 with their writing skills and helping teachers get their students excited about writing. Our work is based on the understanding that strong writing skills are fundamental to future success and that great leaps in learning can be made when skilled tutors work one-on-one with students.

In-School Programs: 826 Valencia partners with public schools throughout San Francisco to collaboratively develop writing curricula. We also bring teams of 826 staff and volunteer tutors to partner schools where we support students 3:1 with writing projects. In FY24, we supported 22 teachers and 788 students at 5 schools, establishing regular weekly partnerships with classrooms and supporting a variety of writing projects. One highlight was our Young Authors Book Project in spring 2024. We worked with tenth and eleventh grade students at Balboa High School, where students wrote autoethnographies, which were published in a book entitled, "Universe of Memories," with a foreword written by guest teaching artist, author Daniel Nayeri.

Field Trip Programs: 826 Valencia hosts storytelling/bookmaking field trips for elementary schools at its Mission Center, creative storytelling field trips for elementary schools at its Mission Bay Center, and podcasting field trips for middle and high schools at its Tenderloin Center. In FY24, we served 3,950s students with workshops. Our Tenderloin Center had 89 podcasting field trips Our students' 1,664 podcasts reached over 29,000 listeners through our SoundCloud page.

Afterschool: 826 Valencia provides free after-school tutoring and writing support at five locations in San Francisco, including our three Writing Centers and our partner schools, Buena Vista Horace Mann (BVHM) and Dr. Charles R. Drew Preparatory Academy. Students enroll for a minimum of two days per week for homework and individual support with reading and writing. Together, these programs served over 450 students in 2023-24. 826 is always looking for new ways to amplify our students' voices and in FY24, students in our after-school programs wrote stories about imaginary friends in collaboration with 826 National and Paramount Studios. Students were published in an anthology showcasing their creative creatures, and some even attended a special premiere of the Paramount movie "IF" with their families.

OTHER PROGRAM SERVICES 6: Leadership and Future Pathways:826 provides middle and high schoolers with opportunities to build skills, knowledge, and resources that strengthen the high school-to-college-to-career pathway. In FY24, we awarded five 4-year \$20,000 college scholarships to graduating seniors who will also receive ongoing college persistence and completion support from our partner ScholarMatch. We provided another 265 twelfth-graders with college application essay support through in-person workshops, both at our centers and with partner schools. Our Youth Leadership Advisory Board and Middle School Leadership Program offered paid internships, leadership development, and career readiness support to 87 teens. We also provided hands-on work experience and stipends to 56 high school and college students and transitional aged youth (TAY) who interned with our education, volunteer, design, and store teams. OTHER PROGRAM SERVICES 7: Other Program Accomplishments include the operation of 2 retail stores. The stores sell educational materials, books for children, and other whimsical childrens toys, and serve as a community touch-point in the neighborhoods where we operate.
