HILL HOUSE ALSO OFFERS AN 11 WEEK SUMMER PROGRAM TO FAMILIES IN THE CITY OF BOSTON WHICH INCLUDES WEEKLY THEMES, ADVENTUROUS ACTIVITIES, FIELD TRIPS, ACTION PACKED SPORTS AND GAMES. SUMMER CAMP OPTIONS INCLUDE DAY CAMP (AGES 5-12), KIDDIE KAMP (AGES 3-5), AND AN LIT PROGRAM AGES (13-15). DURING FISCAL YEAR 2024, THERE WERE MORE THAN 4,734 REGISTRANTS FOR THESE PROGRAMS.
