1 Briefly describe the organization's mission or most significant activities: Mental Health ResiliencyIn 2022, the Foundation recognized the unique emotional burdens that children of first responders carry. We added our Resiliency Program that empowers children to cope with stress, manage their fears and build mental resilience. The goal of the program is to protect and strengthen the mental resiliency of the children of police, firefighters, sheriffs, Emergency Medical Technicians, and 911 dispatchers. In 2024, the program was available to first responder families in eight states: Arizona, California, Florida, Hawaii, New Jersey, New York, Tennessee, and Texas. The program continues to develop and is expected to expand into more states. In 2024, this program served 153 first responder children, providing 2,720 hours of free, one-on-one mental health counseling by culturally competent, licensed professionals.Financial AssistanceThis program honors the sacrifice first responders make by providing critical financial assistance when misfortune strikes by continuing

First Responders Children's Foundation provides financial support to children who have lost a parent in the line of duty as well as families enduring significant financial hardship due to tragic circumstances. First Responders Children's Foundation also supports, promotes, and facilitates educational activities and programs created and operated by first responder organizations whose purpose is to benefit children or the community at large.

Public service announcements are valued based on the number of times the announcements are broadcast and the period in which the advertisements are aired at the television or radio stations equivalent advertising rate charged to paying customers. The fair value of the public service announcements totaled \$22,354,420 for the year ended December 31, 2024.

During 2024, the Foundation received toy donations valued at approximately \$2,800,000, which were subsequently delivered around the country.
