CIRI ACHIEVES THIS MISSION BY PROVIDING A COMPASSIONATE ARRAY OF HIGH-QUALITY LEGAL, SOCIAL AND EDUCATIONAL PROGRAMMING AND BY PROMOTING CROSS CULTURAL UNDERSTANDING AND DECENT TREATMENT FOR ALL.

REFUGEE RESETTLEMENT & EMPLOYMENT SERVICES: ANNUALLY, CIRI ASSISTS ALMOST 600 REFUGEES TO RESETTLE AND REBUILD THEIR LIVES IN THE UNITED STATES. IN 2024, CIRI ALSO ASSISTED OVER 130 AFGHAN PAROLEES AND OVER 470 UKRAINIAN PAROLEES. REFUGEES AND PAROLEES HAVE FLED WAR AND PERSECUTION IN THEIR NATIVE COUNTRIES AND IN MANY CASES HAVE SPENT YEARS, EVEN DECADES, IN REFUGEE CAMPS. CIRI STAFF FOCUSES ON MEETING THE IMMEDIATE BASIC NEEDS OF NEW REFUGEES, AND ASSISTS WITH EMPLOYMENT, HOUSING, SCHOOL READINESS AND SUCCESS IN THE US EDUCATION SYSTEM, ACCESSING HEALTH SERVICES, AND OTHER SERVICES SO THEY MAY THRIVE IN THEIR NEW COMMUNITIES. SUPPORT IS PROVIDED FOR UP TO 5 YEARS FROM INITIAL RESETTLEMENT.

PROJECT RESCUE PROVIDES STATEWIDE TRAINING TO SERVICE PROVIDERS AND LAW ENFORCEMENT ON VICTIM IDENTIFICATION AND OUTREACH TO INCREASE PUBLIC AWARENESS. THE PROGRAM ALSO COLLABORATED WITH STATE AND NATIONAL NETWORKS TO SECURE SAFETY AND RESETTLING OF UNACCOMPANIED MINORS IN SHELTER AND AS THEY MOVE FROM SHELTER TO THEIR SPONSORS/FAMILY MEMBERS.
