ITS CENTRALLY LOCATED, STATE-OF-THE-ART CENTER PROVIDES CRUCIAL, HANDS-ON PROGRAMS AND SERVICES TO LONG ISLAND INDIVIDUALS AND CAREGIVERS, WHO ARE COPING WITH THE CHALLENGES OF LIVING WITH DEMENTIA. THE CENTER PROVIDES PROGRAMMING AND SERVICES FOR EVERY STAGE OF THE DISEASE, FROM PRE-DIAGNOSIS THROUGH END-OF-LIFE.
