BOYS TOWN IS ONE OF ISRAEL'S PREMIER INSTITUTIONS FOR EDUCATING THE COUNTRY'S NEXT GENERATION OF LEADERS IN THE FIELDS OF TECHNOLOGY, COMMERCE, EDUCATION, AND PUBLIC SERVICE. SINCE ITS FOUNDING IN 1948, BTJ HAS PURSUED ITS MISSION OF TURNING YOUNG BOYS FROM LIMITED BACKGROUNDS INTO YOUNG MEN WITH LIMITLESS FUTURES. FROM JUNIOR HIGH THROUGH THE COLLEGE LEVEL, THE THREE-PART CURRICULUM AT BOYS TOWN: ACADEMIC, TECHNOLOGICAL AND TORAH IS DESIGNED TO TURN OTHERWISE DISADVANTAGED ISRAELI YOUTH INTO PRODUCTIVE CITIZENS OF TOMORROW. THE CAMPUS, LOCATED ON 18 BEAUTIFUL ACRES IN THE BAYIT VEGAN NEIGHBORHOOD OF JERUSALEM, OVERLOOKING THE JUDEAN HILL, IS A HOME AWAY FROM HOME FOR STUDENTS FROM DIVERSE BACKGROUNDS, REPRESENTING THE ETHNIC MOSAIC THAT IS ISRAEL TODAY.

EVERY BTJ STUDENT RECEIVES SCHOLARSHIP ASSISTANCE AT SOME LEVEL. THIS VITAL SUPPORT ENSURES THAT NO STUDENT WHO QUALIFIES ACADEMICALLY IS DENIED A BOYS TOWN JERUSALEM EDUCATION. THE OCTOBER 7, 2023 WAR HAS GREATLY INTENSIFIED THE ECONOMIC DISTRESS OF LARGE NUMBERS OF STUDENTS, AS MANY PARENTS LOST THEIR JOBS AND BUSINESSES. BOYS TOWN JERUSALEM WAIVED A HIGH PERCENTAGE OF TUITION FEES DUE TO THE WAR'S ECONOMIC CONSTRAINTS THAT SIGNIFICANTLY INCREASED THE NEED FOR SCHOLARSHIP ASSISTANCE. STEM PROGRAMS - BOYS TOWN JERUSALEM HAS EVOLVED FROM A MAKESHIFT TRADE SCHOOL TEACHING PRINTING AND CARPENTRY INTO A WORLD-CLASS TECHNOLOGICAL CENTER, PREPARING STUDENTS FOR TODAY'S CAREERS IN ELECTRONICS, COMPUTER PROGRAMMING AND NETWORKING, CYBERSECURITY, AND APPLIED ENGINEERING. BOYS TOWN JERUSALEM INAUGURATED THE VERY FIRST CISCO NETWORKING ACADEMY IN THE ENTIRE MIDDLE EAST, AND HAS PIONEERED STEM (SCIENCE, TECHNOLOGY, ENGINEERING, MATHEMATICS) EDUCATION IN ISRAEL.

TO HELP ACHIEVE THESE EXCEPTIONAL RESULTS, BOYS TOWN JERUSALEM PROVIDES A REGULAR PROGRAM OF TUTORING FOR STUDENTS REQUIRING ASSISTANCE IN ALL SUBJECT AREAS. THE OUTBREAK OF THE OCTOBER 7, 2023 WAR INITIALLY BROUGHT ABOUT AN ERRATIC SCHEDULE FOR STUDIES ON CAMPUS, WITH CONSTANTLY CHANGING SECURITY GUIDELINES. IN TIME, THE HARSH EMOTIONAL AND FINANCIAL DILEMMAS TRIGGERED BY THE WAR BECAME HIGHLY DETRIMENTAL TO LARGE NUMBERS OF OUR STUDENTS' ACADEMIC PROGRESS. A SIGNIFICANT LONG-TERM PROGRAM NOW OFFERS STUDENTS INTENSIFIED TUTORING IN MATH, ENGLISH, PHYSICS, HEBREW LANGUAGE, & JEWISH STUDIES. THE TUTORING PROGRAM, AT NO CHARGE TO PARENTS, IS FUNDED SOLELY BY BOYS TOWN JERUSALEM. SUMMER ENRICHMENT PROGRAMS - \$160,000 - BOYS TOWN JERUSALEM'S CAMPUS IS UTILIZED YEAR-ROUND. WHEN THE REGULAR SCHOOL YEAR CONCLUDES IN JUNE, SPECIAL SUMMER PROGRAMS ARE CONDUCTED, EACH DESIGNED TO BENEFIT A PARTICULAR GROUP OF STUDENTS AND THEIR OWN SPECIAL NEEDS. THESE INCLUDE DAY CAMPS FOR JUNIOR HIGH SCHOOL STUDENTS, WITH CLASSROOM STUDY FOLLOWED BY SPORTS, CAMPING, FIELD TRIPS AND ACTIVITIES BOTH ON AND OFF THE BTJ CAMPUS; TUTORING SESSIONS FOR HIGH SCHOOL STUDENTS TO BOLSTER THEIR SKILLS IN SPECIFIC SUBJECT AREAS; AND ENRICHMENT CLASSES FOR HIGH-ACHIEVING HIGH SCHOOL STUDENTS. SUPPLEMENTAL ASSISTANCE FOR IMMIGRANT STUDENTS - \$245,000 - SINCE 2001, BOYS TOWN JERUSALEM HAS SERVED AS THE FIRST HOME IN ISRAEL FOR SOME OF THE COUNTRY'S NEWEST CITIZENS PARTICULARLY YOUNG IMMIGRANTS FROM FRANCE, THE FORMER SOVIET UNION AND ETHIOPIA. BOYS TOWN JERUSALEM PROVIDES THEM WITH FULL ROOM AND BOARD, INCLUDING SPECIAL PROGRAMS AND ACTIVITIES DURING SCHOOL VACATIONS, MEDICAL SERVICES AND EVEN POCKET MONEY AND A GIFT ON THEIR BIRTHDAYS. ROBOTICS EQUIPMENT UPDATED - \$25,000 - NEW UPGRADED ROBOTICS EQUIPMENT AND MATERIALS WERE PURCHASED FOR OUR ROBOTICS CENTER, ENABLING THE BTJ ROBOTICS TEAMS FROM GRADES 8 -12 TO DESIGN AND BUILD CUSTOM-MADE ROBOTS TO COMPETE (AND WIN AWARDS) IN REGIONAL AND NATIONAL ISRAELI ROBOTICS COMPETITIONS.
