WE DELIVER OUR PROGRAMS BY WORKING IN COLLABORATION WITH INDIVIDUALS, COMMUNITIES, LOCAL ORGANIZATIONS, HEALTH SYSTEMS, AND NATIONAL GOVERNMENTS TO ADVANCE SEXUAL AND REPRODUCTIVE HEALTH AND RIGHTS AND GENDER EQUALITY. WE ACHIEVE OUR PROGRAM RESULTS THROUGH TRAINING, COMMUNITY ENGAGEMENT, STRENGTHENING SERVICE DELIVERY, AND SUPPORTING POLICY DEVELOPMENT. IN FY24, ENGENDERHEALTH CONTINUED ITS TRADITION OF PROVIDING HIGH-QUALITY COMPREHENSIVE SEXUAL AND REPRODUCTIVE HEALTH (SRH) SERVICES. WE PROVIDED CONTRACEPTIVE CARE TO AN ESTIMATED 1,279,900 CLIENTS, GENERATING AN ESTIMATED 4,002,300 COUPLE YEARS OF PROTECTION (CYPS) AND PREVENTING 2,100 MATERNAL DEATHS, 31,600 CHILD DEATHS, AND 678,800 UNSAFE ABORTIONS. OUR WORK RESULTED IN AN ESTIMATED \$142,046,900 OF SAVINGS IN DIRECT HEALTHCARE COSTS THAT WOULD HAVE BEEN INCURRED BY FAMILIES OR THE HEALTHCARE SYSTEM IF IMPROVED HEALTHCARE SERVICES HAD NOT BEEN PROVIDED. IN ADDITION TO CONTRACEPTIVE CARE, ENGENDERHEALTH'S PROJECT-SUPPORTED HEALTH FACILITIES PROVIDED 1,297 FISTULA REPAIR SURGERIES, AND MORE THAN 113,108 OBSTETRIC SURGERIES. ENGENDERHEALTH ALSO SUPPORTED SERVICES FOR SURVIVORS OF 114,648 GENDER-BASED VIOLENCE (GBV) INCIDENTS. ENGENDERHEALTH REACHED OVER 4.1 MILLION PEOPLE DIRECTLY WITH INFORMATION ON SRH AND RIGHTS (SRHR) IN FY24, INCLUDING MESSAGING ON CONTRACEPTION, FISTULA, CAC, GBV, AND OTHER ELEMENTS OF SRHR. IN FY24, ENGENDERHEALTH TRAINED MORE THAN 10,100 CLINICAL STAFF (E.G., SURGEONS, DOCTORS, NURSES, AND MIDWIVES), 8,600 PHARMACISTS AND ASSOCIATES, AND MORE THAN 3,200 COMMUNITY HEALTH WORKERS ACROSS 17 PROJECTS. TRAINING AREAS FOR CLINICAL STAFF INCLUDED MODERN CONTRACEPTIVE METHOD SERVICE PROVISION, CAC, GBV, AND/OR PROVISION OF MALE AND YOUTH FRIENDLY SERVICES. IN ADDITION TO HEALTHCARE PERSONNEL, ENGENDERHEALTH TRAINED 28,900 INFLUENTIAL COMMUNITY MEMBERS INCLUDING ADOLESCENT CHAMPIONS, YOUNG PEOPLE, RELIGIOUS AND COMMUNITY LEADERS, AND POLICE IN GBV PREVENTION GYST SRHR ADVOCACY AND DISABILITY INCLUSION. IN FY24, ENGENDERHEALTH HAD 31 ACTIVE PROGRAMS IN 16 COUNTRIES (BENIN, BURKINA FASO, BURUNDI, COTE D'IVOIRE, THE DEMOCRATIC REPUBLIC OF CONGO, ETHIOPIA, GUINEA, INDIA, KENYA, MADAGASCAR, MALI, MOZAMBIQUE, NIGERIA, RWANDA, SENEGAL, AND TANZANIA). ILLUSTRATIVE PROGRAM UPDATES BELOW, WE PROVIDE PROJECT EXAMPLES ORGANIZED BY OUR CORE IMPACT AREAS: SRHR (INCLUDING CONTRACEPTION AND CAC), GBV, AND MATERNAL HEALTH (MH). SRHR: ENGENDERHEALTH EMPLOYS A RIGHTS-BASED APPROACH THAT EMPHASIZES CLIENTS' FULL, FREE, AND INFORMED CHOICE OF CONTRACEPTIVE METHODS AND EXPANDS ACCESS TO HIGH-QUALITY SRHR INFORMATION AND SERVICES, INCLUDING CAC. DURING FY24, IN TANZANIA, ENGENDERHEALTH PARTNERED WITH THE MINISTRY OF HEALTH AND OTHER STAKEHOLDERS, INCLUDING YOUTH, THROUGH THE BUILDING RIGHTS FOR IMPROVED GIRL'S HEALTH IN TANZANIA PROJECT TO DEVELOP TANZANIA'S PRIORITY COMMITMENTS FOR ADOLESCENT HEALTH AND WELLBEING, LAUNCHED IN OCTOBER 2023 BY THE MINISTER OF HEALTH. AS PART OF THE TASKFORCE COMMISSIONED TO REVIEW THE COMMITMENTS, ENGENDERHEALTH SUPPORTED A SERIES OF CONSULTATION MEETINGS AND SUCCESSFULLY ADVOCATED FOR THE INCLUSION OF COMMITMENTS ON THE PREVENTION OF SEXUALLY TRANSMITTED INFECTIONS AND HIV, GBV, AND UNINTENDED AND UNWANTED ADOLESCENT PREGNANCIES, AS WELL AS THE PROMOTION OF OPTIMUM NUTRITION. IN NIGERIA, ENGENDERHEALTH ADVOCATED WITH GOVERNMENT PARTNERS THROUGH THE HORMONAL INTRAUTERINE DEVICE ROLLOUT AND SCALE-UP PROJECT TO EXPAND STATE BUDGETS AND ANNUAL OPERATING PLANS TO INCREASE RESOURCES FOR FAMILY PLANNING. AS A RESULT, THE STATE GOVERNMENT ALLOCATIONS TO FAMILY PLANNING BUDGET LINES INCREASED BY 60% IN BAUCHI STATE AND BY 300% IN SOKOTO STATE FROM 2023 TO 2024. GBV: PREVENTING AND ADDRESSING GBV AND SUPPORTING SURVIVORS ARE ESSENTIAL TO IMPROVING THE HEALTH OF ALL PEOPLE. OUR GBV ACTIVITIES FOCUSED ON ENSURING THAT HEALTH AND RELATED SYSTEMS SUPPORT THE MONITORING AND PREVENTION OF AND RESPONSE TO GBV. IN FY24, ENGENDERHEALTH PARTNERED WITH THE MINISTRY OF HEALTH AND OTHER STAKEHOLDERS IN ETHIOPIA THROUGH THE RIGHTS-BASED APPROACH FOR ENHANCING SRHR PROJECT TO UPDATE THE GBV RESPONSE TRAINING PACKAGE FOR HEALTH WORKERS. THIS REVISED PACKAGE, ENDORSED BY THE GOVERNMENT IN AUGUST 2023, INCORPORATES EXERCISES FROM ENGENDERHEALTH'S GYST STAFF TRAINING MANUAL, AS WELL AS NEW SECTIONS ON GBV IN HUMANITARIAN SETTINGS AND GBV CARE AND SUPPORT FOR PEOPLE WITH DISABILITIES. IN JUNE 2024, THE FEDERAL MINISTRY OF HEALTH PUBLICLY RECOGNIZED ENGENDERHEALTH'S SIGNIFICANT CONTRIBUTIONS TO GENDER MAINSTREAMING, WOMEN'S EMPOWERMENT, AND GBV PREVENTION IN THE HEALTH SECTOR. MATERNAL HEALTH: IN FY24, ENGENDERHEALTH CONTINUED TO EXPAND PATIENT CENTERED, SAFE, AFFORDABLE, AND RESPECTFUL MATERNAL AND OBSTETRIC CARE. THROUGH THE MOMENTUM SAFE SURGERY IN FAMILY PLANNING AND OBSTETRICS (MOMENTUM SAFE SURGERY) PROJECT, ENGENDERHEALTH AND OUR PARTNERS CONTINUED TO ENSURE A SUPPORTIVE ENVIRONMENT FOR PATIENT-CENTERED, SAFE, AFFORDABLE, AND RESPECTFUL MATERNAL AND OBSTETRIC CARE. IN MALI, THE PROJECT BEGAN TO CHAMPION THE DEVELOPMENT OF A NEW 12-MONTH MATERNAL HEALTH PERISURGE CERTIFICATION PROGRAM, A CERTIFICATION FOR PHYSICIANS ON THE PROVISION OF SAFE SURGICAL SERVICES, IN 2021. THEN, IN FY24, THE PROJECT PROVIDED FINANCIAL AND TECHNICAL SUPPORT TO SUCCESSFULLY ADVOCATE WITH THE MINISTER OF HEALTH AND SOCIAL DEVELOPMENT TO INSTITUTIONALIZE THE PROGRAM AS A STANDARD COMPONENT IN CONTINUING MEDICAL EDUCATION. THE ADOPTED RESOLUTION REQUIRES ALL MATERNITY WARD DOCTORS TO COMPLETE TRAINING EVERY FIVE YEARS. IN ADDITION, IN NIGERIA, THE PROJECT SUPPORTED IMPLEMENTATION OF TOOLS TO MONITOR AND AUDIT MATERNAL, PERINATAL, AND CHILD DEATHS; CESAREAN SECTION RATES; AND SURGICAL SAFETY. RESULTS SHOW AN INCREASE IN USE OF THESE TOOLS AND A REDUCTION IN MATERNAL DEATHS IN PROJECT-SUPPORTED SITES.
