THAT MEANS EDUCATING PEOPLE ACROSS THE COUNTRY, INCLUDING OUR MEMBERS, LAWMAKERS, AND OTHER INFLUENCERS ABOUT THE PERNICIOUS IMPACTS OF ANTI-CHOICE POLICIES, AS WELL AS WORKING ALONGSIDE OUR PARTNERS TO PROMOTE PROGRESSIVE, PROACTIVE POLICIES THAT ADVANCE REPRODUCTIVE FREEDOM. THEY PROVIDE INPUT ON ORGANIZATIONAL STRATEGY RELATING TO PRIORITY LEGISLATION AND ANTI-CHOICE LEGISLATIVE INITIATIVES, INCLUDING ACCOUNTABILITY CAMPAIGNS FOR STATE AND FEDERAL ELECTED OFFICIALS, AS WELL AS ENGAGING NARAL'S MEMBERSHIP EFFECTIVELY TO ADVOCATE IN WASHINGTON AND IN THE HALLS OF STATE GOVERNMENT.
