FOUNDED IN 1978, NAPO IS THE STRONGEST UNIFIED VOICE IN SUPPORTING LAW ENFORCEMENT OFFICERS IN THE US. NAPO REPRESENTS MORE THAN 2,000 POLICE UNITS AND ASSOCIATIONS, OVER 241,000 SWORN LAW ENFORCEMENT OFFICERS, AND MORE THAN 80,000 CITIZENS WHO SHARE A COMMON DEDICATION TO FAIR AND EFFECTIVE CRIME CONTROL AND ENFORCEMENT.

IT IS THE AIM OF NAPO TO STIMULATE MUTUAL COOPERATION BETWEEN LAW ENFORCEMENT ORGANIZATIONS AND TO ASSIST IN THE ECONOMIC, SOCIAL, AND PROFESSIONAL ADVANCEMENT OF ALL LAW ENFORCEMENT OFFICERS, WHETHER ACTIVE OR RETIRED.
