WE HOLD PERPETRATORS ACCOUNTABLE, PROTECT PEOPLE FROM INJUSTICE, AND STRENGTHEN INSTITUTIONS THAT SAFEGUARD UNIVERSAL RIGHTS. FOR ALMOST 50 YEARS, HUMAN RIGHTS FIRST HAS BUILT BIPARTISAN COALITIONS AND WORKED WITH LAWYERS AND HUMAN RIGHTS DEFENDERS TO ADDRESS GLOBAL CHALLENGES. THE ORGANIZATION IS BASED IN NEW YORK, WASHINGTON, D.C., AND LOS ANGELES.

WORKING WITH A NATIONWIDE NETWORK OF PRO BONO ATTORNEYS, THE ORGANIZATION SCREENS CASES, TRAINS LAWYERS, AND WORKS TO ENSURE THAT ASYLUM SEEKERS AND IMMIGRANTS HAVE ACCESS TO DUE PROCESS. IN 2024, HUMAN RIGHTS FIRST ASSISTED APPROXIMATELY 2,077 REFUGEES AND ASYLUM 1,327,951. ASYLUM SEEKERS FROM 83 COUNTRIES, SECURING PROTECTION FROM 382 CLIENTS AND FAMILY MEMBERS.
