CRIME VICTIMS AND DV (SEE SCHEDULE O):EMPIRE JUSTICE LEADS THE NEW YORK CRIME VICTIMS LEGAL NETWORK, A PARTNERSHIP OF CIVIL LEGAL ORGANIZATIONS AND VICTIM ASSISTANCE PROGRAMS THAT CONNECTS VICTIMS OF CRIME WITH INFORMATION AND ASSISTANCE THROUGH ITS MULTIFACETED ONLINE TOOL (NY CRIME VICTIMS LEGAL HELP). IN 2024, OVER 22,520 PEOPLE USED THIS TOOL TO ACCESS KNOW-YOUR-RIGHTS RESOURCES AND CONNECT WITH AGENCIES WHO COULD HELP THEM. IN ADDITION TO LEADING THE NETWORK, EMPIRE JUSTICE IS ALSO A DIRECT SERVICES PARTNER, PROVIDING LEGAL SERVICES TO MORE THAN 425 CRIME VICTIMS IN MONROE COUNTY, THE HUDSON VALLEY AND ON LONG ISLAND. ON LONG ISLAND, ADVOCATES HELPED MORE THAN 120 FAMILIES FACING EVICTION IN 2024 WITH EMERGENCY RENTAL ASSISTANCE PROGRAM FUNDING THROUGH THE OFFICE OF TEMPORARY AND DISABILITY ASSISTANCE (OTDA), THROUGH A SUBCONTRACT WITH LEGAL SERVICES OF LONG ISLAND.
