DURING THE COURSE OF 2024, AMERICA'S AGENDA ("AAHCA") CONTINUED OUR ONGOING WORK TO BUILD AND STRENGTHEN BROAD CITIZEN COALITIONS THAT UNITE BUSINESSES, LABOR UNIONS, AND OTHER STAKEHOLDERS IN EFFECTIVE ADVOCACY TO ACHIEVE REFORMS THAT WILL ASSURE THAT EVERY AMERICAN HAS AFFORDABLE ACCESS TO HIGH-QUALITY HEALTHCARE. AS THE COST OF PRESCRIPTION DRUGS HAS EMERGED AS THE FASTEST-GROWING COMPONENT OF OVERALL HEALTH COSTS, AAHA HAS ADOPTED REDUCTION OF PRESCRIPTION DRUG COSTS AS A HIGH PRIORITY CONCERN AND FOCUS OF AAHCA ACTIVITY. AAHCA-ORGANIZED ADVOCACY CAMPAIGNS HAVE RESULTED IN ENACTMENT OF AMERICA'S AGENDA-DESIGNED STRATEGIES TO REDUCE PRESCRIPTION DRUG COSTS AND CAPTURE SUBSTANTIAL SAVINGS FOR PATIENTS, TAXPAYERS, STATE GOVERNMENT, AND PUBLIC EMPLOYEES IN SEVERAL STATES ACROSS THE COUNTRY. EACH OF OUR AAHCA STATE CAMPAIGNS HAS BUILT ON THE SUCCESS OF OUR POLICY INITIATIVE IN NEW JERSEY, WHERE IMPLEMENTATION OF THE AMERICA'S AGENDA-DESIGNED PUBLIC POLICY STRATEGY FOR CREATING A DYNAMICALLY COMPETITIVE MARKETPLACE FOR PHARMACY BENEFIT MANAGERS CAPTURED \$2.52 BILLION IN PRESCRIPTION DRUG SAVINGS OVER 5 YEARS FOR STATE TAXPAYERS AND THE NEW JERSEY STATE EMPLOYEES HEALTH PLAN. AAHCA'S FEDERAL MEDICARE REFORM ADVOCACY INITIATIVE AIMS TO ELIMINATE PERVERSE PRESCRIPTION BENEFIT MANAGER (PBM) INCENTIVES TO PROVIDE MEDICARE PARTICIPANTS HIGHER, RATHER THAN LOWER, PRICED DRUGS AND PREVENT PBM CONFLICTS OF INTEREST THAT DRIVE COSTS HIGHER FOR AMERICA'S SENIORS. THE FOLLOWING EXAMPLES HIGHLIGHT ACCOMPLISHMENTS OF CONTINUING AAHCA ADVOCACY INITIATIVES OVER THE COURSE OF 2024: - IN COLORADO, DURING 2024, AAHCA EXPANDED OUR ADVOCACY COALITION OF COLORADO CITIZEN ORGANIZATIONS THAT HAD BUILT THE MOMENTUM LEADING TO THE 2022 ENACTMENT OF COLORADO'S COMPETITIVE PHARMACY BENEFITS MANAGER MARKETPLACE ACT. THE EXPANDED COALITION UNITED AROUND CORE PRINCIPLES FOR A BROADER PUBLIC AND PRIVATE SECTOR PRESCRIPTION DRUG MARKET REFORM WITH THE GOAL OF SUBSTANTIALLY REDUCING COST OF PRESCRIPTION DRUGS FOR PATIENTS IN ALL OF COLORADO'S PUBLIC AND PRIVATE SECTOR INSURANCE PROGRAMS BY ELIMINATING THE PRICE-INCREASING PRESCRIPTION DRUG MANAGER ("PBM") PRACTICE OF PRESCRIPTION DRUG ARBITRAGE AND BY CREATING A NEW, COMPETITIVE MARKETPLACE FOR PBM SERVICES WITH TRANSPARENT, COMPETITIVE DOLLAR-VALUE PRICING. COLORADO AAHCA COALITION ORGANIZATIONS ADVOCATED FOR THE URGENCY OF PRIORITIZING ENACTMENT OF EFFECTIVE PRESCRIPTION DRUG AFFORDABILITY REFORMS IN THE NEXT LEGISLATIVE SESSION, COMMENCING IN 2025, AND AS A RESULT OF THESE EFFORTS OVER THE COURSE OF 2024, A BIPARTISAN GROUP OF LEGISLATIVE LEADERS STEPPED FORWARD AS ADVOCATES AND PROSPECTIVE SPONSORS IN THE COLORADO LEGISLATURE. - IN MINNESOTA, AAHCA REMOBILIZED OUR ADVOCACY CAMPAIGN PARTNER ORGANIZATIONS WHO HAD WON ENACTMENT OF MINNESOTA'S 2021 PBM REVERSE AUCTION STATUTE FOR THE PURPOSE OF DEFENDING AGAINST A 2024 PBM INDUSTRY-BACKED INITIATIVE TO RESCIND THE REFORMS AFTER THEY HAD REDIRECTED TENS OF MILLIONS OF DOLLARS PER YEAR OF PBM GROSS REVENUES BACK TO SAVINGS FOR MINNESOTA TAX-PAYERS AND PUBLIC EMPLOYEE FAMILIES. DURING THE EXTENDED SESSION OF THE 2024 SESSION OF THE MINNESOTA LEGISLATURE, THE ADVOCACY AND EDUCATIONAL WORK OF AAHCA AND OUR CAMPAIGN COALITION PARTNERS ULTIMATELY SUCCEEDED IN THWARTING THE ATTEMPT TO RESCIND THR MINNESOTA'S PBM REVERSE AUCTION REFORM. - IN IOWA, AAHC, IN COORDINATION WITH OUR STATE COALITION PARTNERS, PROVIDED TECHNICAL SUPPORT AND ADVICE TO OFFICERS OF THE STATE ADMINISTRATION - ALIGNED IN GOALS WITH STATE LEGISLATORS TO WHOM AAHCA HAS PROVIDED ADVICE EARLIER IN 2024 - WITH A COMMON OBJECTIVE OF IMPLEMENTING A COMPETITIVE, TECHNOLOGY-ENABLED PBM REVERSE AUTION PROCESS MODELED ON AAHCA PRINCIPLES THAT HAVE CAPTURED BILLIONS OF TAXPAYER DOLLARS IN PRESCRIPTION DRUG SAVINGS FOR STATE GOVERNMENTS AND PUBLIC EMPLOYEE FAMILIES IN NEW JERSEY, COLORADO, AND MINNESOTA. - THE AAHCA COALITION FOR MEDICARE PART D PRESCRIPTION DRUG MARKET REFORMS HAS AIMED ITS FOCUS OVER THE COURSE OF 2023 AND 2024 ON REDUCING PRESCRIPTION DRUG COSTS FOR AMERICA'S SENIORS BY PROHIBITING LINKAGE OF PHARMACY BENEFIT MANAGER INCOME TO THE LIST PRICE OF PRESCRIPTION DRUGS. EXTENSIVE AAHCA ADVOCACY AND PUBLIC EDUATION OVER THE COURSE OF 2024, INCLUDING AN EXTENSIVE ONLINE PUBLIC EDUATION CAMPAIGN, CONTRIBUTED TO THE DECEMBER 2024 AGREEMENT ON A COMMON SET OF PRESCRIPTION DRUG AFFORDABILITY REFORMS BY BIPARTISAN LEADERSHIP IN BOTH THE US SENATE AND THE HOUSE OF REPRESENTATIVES. THE DECEMBER 2024 AGREEMENT WAS GROUNDED IN A SET OF BILLS ADVOCATED FOR BY AAHCA AND ADOPTED UNANIMOUSLY BY THE US SENATE FINANCE COMMITTEE, AND THE ENERGY AND COMMERCE COMMITTEE AND THE WAYS AND MEANS COMMITTEE OF THE US HOUSE OF REPRESENTATIVES. ALTHOUGH THE BROADLY SUPPORTED DECEMBER 2024 PRESCRIPTION DRUG MARKET REFORMS WERE NOT ULTIMATELY VOTED UPON BEFORE CONGRESS ADJOURNED FOR ITS CHRISTMAS RECESS, THEY ARE EXPECTED PROVIDE THE FRAMEWORK FOR CONGRESSIONAL CONSIDERATION OF PRESCRIPTION DRUG AFFORDABILITY REFORM IN THE 119TH CONGRESS.
