OXFAM ALSO JOINED THE CARE CAN'T WAIT COALITION TO ADVOCATE FOR IMPROVED U.S. CARE POLICIES, FOCUSING ON CHILD CARE, PAID FAMILY AND MEDICAL LEAVE, AND HOME AND COMMUNITY-BASED CARE SERVICES. WE AIM TO ENSURE THESE POLICIES ARE CENTRAL IN THE 2024 ELECTIONS AND DEBATED AND PASSED IN 2025.
