THE INTERNATIONAL BIOMEDICAL RESEARCH ALLIANCE ADVANCES THE TRAINING AND CAREER DEVELOPMENT OF FUTURE LEADERS IN BIOMEDICAL RESEARCH THROUGH SCHOLARSHIPS, MENTORSHIP, AND PROFESSIONAL DEVELOPMENT PROGRAMS. IN 2024, IBRA SUPPORTED MORE THAN 40 ACTIVE PARTICIPANTS WITH RESEARCH AND LEADERSHIP TRAINING, DELIVERED OVER 30 DAYS OF PROFESSIONAL DEVELOPMENT PROGRAMMING, AND ENGAGED NEARLY 400 ALUMNI AND CURRENT SCHOLARS REPRESENTING MORE THAN 185 UNIVERSITIES ACROSS 9 COUNTRIES. B. IF APPROPRIATE, THE BOARD OR THE NOMINATING & CORPORATE GOVERNANCE COMMITTEE MAY APPOINT A DISINTERESTED PERSON OR COMMITTEE TO INVESTIGATE ALTERNATIVES TO THE PROPOSED TRANSACTION OR ARRANGEMENT. C. AFTER EXERCISING DUE DILIGENCE, THE BOARD OR NOMINATING & CORPORATE GOVERNANCE COMMITTEE SHALL DETERMINE WHETHER THE ORGANIZATION CAN OBTAIN, WITH REASONABLE EFFORTS, A MORE ADVANTAGEOUS TRANSACTION OR ARRANGEMENT FROM A PERSON OR ENTITY THAT WOULD NOT GIVE RISE TO A CONFLICT OF INTEREST. D. IF A MORE ADVANTAGEOUS TRANSACTION OR ARRANGEMENT IS NOT REASONABLY POSSIBLE UNDER CIRCUMSTANCES NOT PRODUCING A CONFLICT OF INTEREST, THE BOARD OR NOMINATING & CORPORATE GOVERNANCE COMMITTEE SHALL DETERMINE, BY A MAJORITY VOTE OF THE DISINTERESTED DIRECTORS, WHETHER THE TRANSACTION OR ARRANGEMENT IS IN IBRA'S BEST INTEREST, FOR ITS OWN BENEFIT, AND WHETHER IT IS FAIR AND REASONABLE. IN CONFORMITY WITH THE ABOVE DETERMINATION, IT SHALL MAKE ITS DECISION AS TO WHETHER TO ENTER INTO THE TRANSACTION OR ARRANGEMENT. THE NOMINATING & CORPORATE GOVERNANCE COMMITTEE SHALL INTERPRET AND OVERSEE THE IMPLEMENTATION OF THE CONFLICTS OF INTEREST POLICY, REVIEW AND SUGGEST MODIFICATIONS TO IMPROVE THE CONFLICTS OF INTEREST POLICY.

THE PROCESS INCLUDES REVIEW OF COMPARABLE COMPENSATION DATA FROM SIMILARLY SITUATED NONPROFIT ORGANIZATIONS AND IS DOCUMENTED IN THE BOARD MINUTES.
