OUR FAMILY CARE PROGRAM PROVIDED SERVICES TO 272 INDIVIDUALS. THE SERVICES INCLUDED EDUCATIONAL COUNSELING, REFERRAL, AND PROVIDE THE NEEDED RESOURCES WHEN DOMESTIC VIOLENCE, SEXUAL ASSAULT, HUMAN TRAFFICKING OR STALKING OCCURS. ADDITIONALLY, WE HAD 5831 OUTREACH FOR COMMUNITY MENTAL WELLNESS, 43 RHS-SCREENINGS, AND ASSISTED 143 FAMILIES FOR KINSHIP AND ADOPTION NAVIGATOR PROGRAM.
