Urban Tilth is a California nonprofit organization committed to educate diverse communities about organic gardening and to support a network of gardens dedicated to sustainable, local food production. Urban Tilth inspires, hires, and trains local residents to cultivate agriculture, feed our community, and restore relationships to land to build a more sustainable food system, within a just and healthier community.

Fiscal sponsorship relates to costs associated with the management and review of administrative functions for organizations that do not have formal 501c3 status and which have arranged to operate under the umbrella of Urban Tilth. Several of these organizations include Cooperation Richmond, It Takes a Village, Rich City Rides, Moving Forward, Richmond Grows Seed Library, and fCypher Healing Herbs Podcast Project.

4b (Code:) (Expenses \$ 1,732,508 including grants of \$ 435,297) (Revenue \$ 856)

Education Programs is a farm, classroom, and community program at Richmond High School. The institute constitutes an in-class accredited class called "Urban Ecology and American Food Systems": an on-site 8000 square foot farm and a CSA program serving the school community. In addition the Education Program has afterschool programs called; The Healing Movement, The Urban Naturalists, Urban Watershed, and Naturalists Club. The Education and Urban Agriculture also includes our elementary school programs at Verde elementary and Lincoln elementary. At these two sites we manage large gardens, in-school and after-school gardening, nutrition and science programs. It also includes a 40,000 square foot urban farm at Adams Middle School, an abandoned middle school campus in partnership with the west conta costa unified school district. Lastly, The Basins of Relations Watershed Stewardship Program includes training in watershed technology, community engagement, and development of a community trail.

Heal programs support the distribution of healthy foods to food deserts in West Contra Costa County as well as offer healthy and active living workshops, classes, cooking demos, and nutrition classes for the community. This work includes Farm to Table & farmers to families CSA's, Veggie RX, Free farm stands, and community workshops and classes. Activate includes community engagement and outreach supporting raising of awareness of environmental justice issues and climate change challenges facing the fenceline community of Richmond. It includes mutual aid projects like our wildfire preparedness kits that offer resources such as herbs and teas to ease respiratory issues and conditions exacerbated by wildfire and refinery pollution. It includes participation in fire kits and community art projects to raise awareness. Activate also includes hosting cohorts of community members to learn about the topics through the year.

Community Programs is a project open-to-all community farms, gardens, and edible streetscapes located at sites through Richmond. This is centered on nearly two acres of the Richmond Greenway, a former railway line, where we have planted and manage a Berryland, an Edible Forest. Also includes a 42 raised bed community garden also on the Richmond Greenway. We also operate a Garden Technical Assistance team which employs and trains local youth to help other schools, community organizations and churches build and maintain their own gardens.

CAPITAL PROJECT is the purchase and development of the North Richmond Farm, a 3 acreurban farm in North Richmond. Plans are to build a permanent greenhouse, shade house, farm store, interior produce wash and pack and community meeting room, as well as an outdoor amphitheater, cafe and community commercial kitchen and a permanent office and home for Urban Tilth. The capital campaign is raising funds for this major construction project.
