WE ARE COMMITTED TO PRESERVING WILD FELID POPULATIONS IN THEIR NATIVE HABITATS WORLDWIDE, ADDRESSING THE THREATS POSED BY HUMAN ENCROACHMENT AND CONFLICT. WITH NEARLY 40 SPECIES AT RISK OF ENDANGERMENT, OUR WORK FOCUSES ON UNDERSTANDING CARNIVORE ECOLOGY AT THE URBAN-WILDERNESS INTERFACE TO PROMOTE PEACEFUL COEXISTENCE. WE ASSESS FELID POPULATIONS, MOVEMENTS, BEHAVIORS, AND HEALTH TRENDS IN WILD CATS, INCLUDING ZOOONOTIC DISEASES, RECOGNIZING THAT 75% OF HUMAN ILLNESSES ARE ZOOONOTIC IN ORIGIN. OUR INITIATIVES INVOLVE IDENTIFYING KEY HABITAT PATCHES, COLLECTING CRITICAL HEALTH DATA, AND IMPLEMENTING INNOVATIVE CONFLICT-REDUCTION PROGRAMS. SINCE 2014, WE'VE ENGAGED OVER 120,000 INDIVIDUALS GLOBALLY TO FOSTER HARMONY WITH THESE KEYSTONE SPECIES AND SAFEGUARD HEALTHY ECOSYSTEMS. OUR MISSION REMAINS STEADFAST: PREVENTING GLOBAL FELID EXTIRPATION TO ENSURE ECOLOGICAL BALANCE.

WITH INCREASING HABITAT FRAGMENTATION AND HUMAN ENCROACHMENT, OUR WORK FOCUSES ON MITIGATING HUMAN-WILDLIFE CONFLICT AND UNDERSTANDING THE CHALLENGES PUMAS FACE AT THE URBAN-WILDERNESS INTERFACE. USING NON-INVASIVE RESEARCH TOOLS LIKE CAMERA ARRAYS, HAIR AND FECAL SURVEYS, AND CITIZEN SCIENCE, WE COLLECT CRITICAL DATA ON PUMA BEHAVIOR, MOVEMENT, AND HEALTH, INCLUDING ZOOONOTIC DISEASES THAT POSE RISKS TO BOTH WILDLIFE AND HUMANS. IN BOTH REGIONS, WE EMPHASIZE COMMUNITY ENGAGEMENT AND CONFLICT-REDUCTION STRATEGIES. BY COLLABORATING WITH LOCAL COMMUNITIES, WE AIM TO FOSTER COEXISTENCE WITH THESE APEX PREDATORS THROUGH EDUCATIONAL OUTREACH, REAL-TIME TRACKING, AND PRACTICAL SOLUTIONS FOR REDUCING HUMAN-PUMA ENCOUNTERS. SINCE THE PROJECT'S INCEPTION, WE HAVE REACHED TENS OF THOUSANDS OF INDIVIDUALS IN THE BAY AREA AND ORANGE COUNTY, RAISING AWARENESS ABOUT THE CRITICAL ROLE PUMAS PLAY IN MAINTAINING HEALTHY ECOSYSTEMS. AS KEYSTONE SPECIES, PUMAS ARE ESSENTIAL TO ECOLOGICAL BALANCE, AND OUR GOAL IS TO ENSURE THEIR LONG-TERM SURVIVAL DESPITE GROWING ENVIRONMENTAL PRESSURES.

USING ADVANCED TRACKING TECHNOLOGIES AND NON-INVASIVE RESEARCH METHODS, THE PROJECT MONITORS CHEETAH MOVEMENT, HEALTH, AND BEHAVIOR TO BETTER UNDERSTAND THE CHALLENGES THEY FACE, SUCH AS HABITAT LOSS, HUMAN-WILDLIFE CONFLICT, AND DECLINING PREY AVAILABILITY. IN ADDITION TO RIGOROUS SCIENTIFIC RESEARCH, THE PROJECT EMPHASIZES COMMUNITY-BASED EDUCATION AND OUTREACH PROGRAMS, FOSTERING LOCAL STEWARDSHIP AND PROMOTING COEXISTENCE WITH WILDLIFE. BY INTEGRATING RESEARCH WITH EDUCATION AND CONFLICT MITIGATION, THE TSAVO CHEETAH PROJECT IS COMMITTED TO ENSURING THE LONG-TERM SURVIVAL OF CHEETAHS IN ONE OF EAST AFRICA'S MOST ICONIC LANDSCAPES.

THE BAY AREA BOBCAT PROJECT TRACKS BOBCAT POPULATIONS ACROSS FRAGMENTED HABITATS, STUDYING THEIR MOVEMENT, HEALTH, AND INTERACTIONS WITH HUMAN COMMUNITIES. SIMILARLY, THE LIVING WITH LIONS PROGRAM MONITORS PUMA BEHAVIOR AT THE URBAN-WILDERNESS INTERFACE, ENSURING A BETTER UNDERSTANDING OF THESE APEX PREDATORS' ECOLOGICAL ROLES. BOTH INITIATIVES EMPHASIZE THE DEVELOPMENT OF DYNAMIC CONFLICT MITIGATION TOOLS, SUCH AS REAL-TIME TRACKING SYSTEMS AND COMMUNITY OUTREACH STRATEGIES, AIMED AT REDUCING ENCOUNTERS BETWEEN HUMANS AND WILD FELIDS. THESE TOOLS HELP RESIDENTS AND LOCAL AUTHORITIES MANAGE INTERACTIONS WITH WILDLIFE MORE EFFECTIVELY, FOSTERING PEACEFUL COEXISTENCE. THROUGH THESE PROGRAMS, WE COLLECT VITAL HEALTH AND ECOLOGICAL DATA, ENGAGE LOCAL COMMUNITIES, AND WORK TO PRESERVE CALIFORNIA'S CRITICAL CARNIVORE POPULATIONS.

THIS PROJECT WILL UTILIZE CAMERA TRAPS, FECAL ANALYSIS, AND COMMUNITY OUTREACH TO GATHER DATA ON POPULATION HEALTH, DISTRIBUTION, AND THE THREATS THESE SPECIES FACE. A KEY FOCUS WILL BE ON REDUCING DISEASE TRANSMISSION BETWEEN DOMESTIC AND WILD ANIMALS, EMPLOYING A ONE HEALTH APPROACH TO PROTECT BHUTAN'S RICH BIODIVERSITY. THE PROJECT ALSO INCLUDES CAPACITY BUILDING THROUGH TRAINING FOR LOCAL FORESTRY OFFICIALS, ENSURING SUSTAINABLE CONSERVATION PRACTICES FOR THE FUTURE.
