THE JOURNEY HOME PROVIDED HUNGER RELIEF TO THE HOMELESS AND NEEDY IN THE COMMUNITY THROUGH OUR COMMUNITY CAFE PROGRAM. DURING 2024, WE SERVED MEALS SEVEN DAYS A WEEK, PROVIDING OVER 55,500 MEALS. ADDITIONALLY, THE COMMUNITY CAFE PROGRAM PROVIDED BOXES OF FOOD STAPLES, DAIRY AND PRODUCE. APPROXIMATELY 1,000 BOXES WERE DISTRIBUTED TO CLIENTS OF OUR OUTREACH CENTER. THE CAFE BREAD ROOM ALSO PROVIDES BREAD AND BAKED GOODS DAILY FOR CLIENTS TO TAKE AS THEY LEAVE THE CENTER. ALL OF THIS IS PROVIDED AT NO CHARGE TO THE CLIENTS TO MEET BASIC NUTRITIONAL NEEDS AS WELL AS BEING AN ENGAGEMENT TOOL FOR OTHER PROGRAMS.
