THE PEDIATRIC HABILITATION PROGRAM INCLUDES THERAPY IN OCCUPATIONAL, PHYSICAL, AND SPEECH AND LANGUAGE PROCESSING. PEDIATRIC OCCUPATIONAL THERAPY FOCUSED ON FINE MOTOR CONTROL AND SENSORY INTEGRATION FOR KIDS WITH CHILDHOOD DISABILITIES, AUTISM, DEVELOPMENTAL DELAYS, AND PROBLEMS WITH SENSORY INTEGRATION. PHYSICAL THERAPY SERVICES FOCUSED ON GROSS MOTOR CONTROL AND SENSORY INTEGRATIONS FOR KIDS WITH CHILDHOOD DISABILITIES, DEVELOPMENTAL DELAYS, AND DIAGNOSES SUCH AS CEREBRAL PALSY.
