IN THE 2023/24 SEASON, PHILADELPHIA THEATRE COMPANY PRODUCED THREE MAJOR PRODUCTIONS: THE DAZZLING NEW ROCK MUSICAL "MACBETH IN STRIDE" BY TONY-NOMINEE WHITNEY WHITE AND DIRECTED BY PTC'S ARTISTIC DIRECTORS TAIBI MAGAR AND TYLER DOBROWSKY, THE RECENT PULITZER PRIZE-WINNING "COST OF LIVING" DIRECTED BY JEFFREY PAGE, AND THE WORLD PREMIERE OF "THE DUAT" BY ROGER Q. MASON, STARRING PHILADELPHIA LEGEND FRANK X. PTC EMPLOYED OVER 190 THEATRE ARTISTS AND WELCOMED OVER 7,600 PATRONS TO ITS MAINSTAGE PRODUCTIONS.
