ISAS REGULARLY REPORTS ON THE EVALUATION OF MEMBER SCHOOLS AND ON THE ACCREDITATION PROCESS TO STATE COMMISSIONS WHICH HAVE BEEN DELEGATED RESPONSIBILITY FOR INDEPENDENT SCHOOL ACCREDITATION BY STATE EDUCATION DEPARTMENTS OR LEGISLATURES. ISAS IS A MEMBER IN GOOD STANDING OF THE INTERNATIONAL COUNCIL ADVANCING INDEPENDENT SCHOOL ACCREDITATION AND HAS VOLUNTARILY AGREED TO ABIDE BY CRITERIA FOR A GOOD PRACTICE AND TO SUBMIT TO ONGOING EVALUATION OF ITS ACCREDITATION PROCEDURES BY THE COUNCIL.

THE FINANCE COMMITTEE RECOMMENDS TO THE BOARD WHETHER OR NOT THERE IS A CONFLICT. THE BOARD OF DIRECTORS THEN MAKES THE FINAL DETERMINATION IF A CONFLICT OF INTEREST EXISTS. IN THE EVENT OF A CONFLICT OF INTEREST, THE BOARD MEMBER HAS A DUTY (I) TO DISCLOSE THE CONFLICT TO THE OTHER MEMBERS OF THE BOARD OR COMMITTEE; (II) TO REFRAIN FROM ENGAGING IN THE DISCUSSION OR THE ACTION UNDER CONSIDERATION; AND (III) TO RECUSE HIM OR HERSELF FROM ANY VOTE ON THE ACTION BEFORE THE BOARD OR COMMITTEE. NO MEMBER OF THE BOARD OF DIRECTORS OF ISAS SHALL MAKE OR PARTICIPATE IN ANY DECISION, REVIEW, OR EVALUATION IN WHICH THAT PERSON HAS A FINANCIAL INTEREST OF ANY KIND, WHETHER DISCLOSED OR UNDISCLOSED. MEMBERS SHALL NOT MAKE OR PARTICIPATE IN ANY DECISION, REVIEW, OR EVALUATION IN WHICH THAT PERSON HAS A PERSONAL INTEREST (OTHER THAN A FINANCIAL INTEREST) UNLESS THAT PERSON HAS DISCLOSED HIS OR HER PERSONAL INTEREST TO ALL OTHER PARTICIPANTS IN THE DECISION-MAKING PROCESS (OR TO THE BOARD) AND THE BOARD OF DIRECTORS HAS EXPRESSLY CONCLUDED THAT THE INVOLVEMENT OF THAT PERSON WILL NOT RENDER ANY SUBSEQUENT DECISION SUBJECT TO THE APPEARANCE OF IMPROPRIETY, LACK OF OBJECTIVITY, OR UNDUE INFLUENCE. MEMBERS SHALL ALSO NOT MAKE OR PARTICIPATE IN ANY DECISION, REVIEW, OR EVALUATION, WHICH UNIQUELY AFFECTS, OR COULD UNIQUELY AFFECT, THAT PERSON'S SCHOOL IN ANY WAY, WHETHER DISCLOSED OR UNDISCLOSED; PROVIDED, HOWEVER, THAT DIRECTORS MAY REVIEW AND ESTABLISH MEMBERSHIP DUES AND FEES WITHOUT VIOLATING THIS POLICY.
FORM 990, PART VI, SECTION B, LINE 15A	THE BOARD PERFORMS AN ANNUAL WRITTEN PERFORMANCE SURVEY OF THE EXECUTIVE DIRECTOR. EACH BOARD MEMBER SUBMITS AN INDIVIDUAL FORM AND COMMENTS. THE FULL BOARD MEETS TO DISCUSS THE RESULTS OF THE BOARD MEMBERS EVALUATION AND THE SURVEY. IN CONJUNCTION WITH THE PERFORMANCE SURVEY AND BOARD EVALUATIONS, THE BOARD USES AN ANNUAL SURVEY OF COMPENSATION AND BENEFITS FOR ASSOCIATION EXECUTIVES FROM THE INDEPENDENT SCHOOL ASSOCIATION NETWORK AS COMPARABILITY DATA. A DECISION IS THEN MADE REGARDING COMPENSATION FOR THE UPCOMING YEAR. THE PRESIDENT OF THE BOARD OF DIRECTORS DISCUSSES THE RESULTS OF THE EVALUATION, SURVEY AND COMPENSATION PACKAGE WITH THE EXECUTIVE DIRECTOR. THE APPROVAL OF THE FINAL BUDGET WHICH INCLUDES COMPENSATION IS DOCUMENTED IN COMMITTEE MINUTES. THIS PROCESS WAS LAST COMPLETED ON JUNE 9, 2024.
