A SPECIAL SESSION OF THE BOARD OF DIRECTORS WAS CONVENED, AND A DECISION WAS REACHED FOLLOWING DISCUSSION. SUBSEQUENT INCREASES ARE DETERMINED THROUGH AN ANNUAL PERFORMANCE EVALUATION OF THE CO-EXECUTIVE DIRECTORS, INCORPORATING FEEDBACK FROM STAFF, PARTNERS, AND BOARD MEMBERS. EACH YEAR, AVAILABILITY OF FUNDS AND COST-OF-LIVING ADJUSTMENTS ARE ALSO CONSIDERED IN THE FINAL DECISION.
