LUNG DISEASE EDUCATION - IN 2023-24, BREATHE PA'S SCHOOL ASTHMA INITIATIVE PROVIDED SCHOOL AND COMMUNITY-BASED ASTHMA EDUCATION IN 16 SCHOOL DISTRICTS (33 SCHOOLS), DISTRIBUTED 372 STUDENT ASTHMA TOOL KITS TO FAMILIES OF CHILDREN WITH ASTHMA, AND TRAINED 24 PROFESSIONAL STUDENTS IN THE FIELD OF NURSING, COMMUNITY HEALTH, AND RESPIRATORY CARE. BREATHE PA ASTHMA CEU CLASS "CURRENT ASTHMA CLASSIFICATION/TREATMENT GUIDELINES AND BREATH SOUNDS TRAINING WAS COMPLETED BY 19 SCHOOL NURSES REPRESENTING 11 SCHOOLS (4 DISTRICTS) AND ISSUING NURSES A TOTAL OF 57 NCPD OR ACT 48 CREDITS. PARENTS OF CHILDREN WITH ASTHMA RECEIVED 372 EDUCATION KITS FOCUSING ON ASTHMA MANAGEMENT. IN 2023-24, BREATHE PA'S SLEEP APNEA PROGRAM ENGAGED WITH EIGHT LOCAL HEALTHCARE PROVIDERS TO PROMOTE ITS SERVICES AND RESOURCES. THE PROGRAM DELIVERED 23 SLEEP APNEA RESOURCE BOXES TO SENIOR CENTERS AND ELDER CARE HOMES, ENHANCING AWARENESS AND SUPPORT FOR AFFECTED INDIVIDUALS. ADDITIONALLY, FOUR SLEEP GROUPS WERE CONDUCTED WITH A TOTAL OF 58 PARTICIPANTS, ARCHIVING 100% OF ALL SESSIONS. IN THE PAST YEAR, LUNG DISEASE EDUCATION INITIATIVES WERE SUCCESSFULLY DELIVERED TO 317 HEALTHCARE PROFESSIONALS AND 85 INDIVIDUALS LIVING WITH CHRONIC LUNG DISEASE ACROSS 27 LOCATIONS WITHIN OUR SERVICE AREA. THESE EDUCATIONAL SESSIONS EQUIPPED PATIENTS WITH ESSENTIAL KNOWLEDGE REGARDING MEDICATIONS, THE PROPER USE OF MEDICAL DEVICES, UNDERSTANDING DISEASE PROCESSES, CARE AND MAINTENANCE OF EQUIPMENT, EFFECTIVE COMMUNICATION WITH HEALTHCARE PROVIDERS, AND STRATEGIES FOR DISEASE MANAGEMENT. ON MARCH 14TH AND 15TH, 2024, BREATHE PA HOSTED THE 10TH ANNUAL TUBERCULOSIS CONFERENCE VIRTUALLY, ATTRACTING A TOTAL OF 311 PARTICIPANTS. OF THOSE PARTICIPANTS, 171 NURSES AND 25 RESPIRATORY THERAPISTS EARNED CONTINUING EDUCATION UNITS TOWARDS THEIR CREDENTIALS.

TOBACCO EDUCATION AND CESSATION- STAFF/ADMINISTRATION TRAINING - THIS PROGRAM IS DESIGNED FOR PRIMARY, SECONDARY, AND HIGHER EDUCATION STAFF AND ADMINISTRATION AS PART OF A COMPREHENSIVE APPROACH TO TOBACCO AND NICOTINE EDUCATION. ALL ASPECTS OF TOBACCO AND NICOTINE USE ARE ADDRESSED, INCLUDING CIGARETTES, SMOKELESS TOBACCO, ELECTRONIC CIGARETTES, MARIJUANA, HOOKAH, CIGARS, AND PIPES. USING A VARIETY OF VISUALS, SCHOOL STAFF AND ADMINISTRATORS LEARN HOW TO IDENTIFY DEVICES AND THE DEVASTATING EFFECTS OF NICOTINE. 482 INDIVIDUALS PARTICIPATED IN THE STAFF/ADMINISTRATION TRAINING. SMOKELESS SATURDAY IS AN ALTERNATIVE OR COMPLEMENT TO FINE OR SUSPENSION FOR STUDENTS WHO HAVE BEEN FOUND WITH TOBACCO OR NICOTINE PRODUCTS ON SCHOOL PROPERTY. IT IS A HALF-DAY, DIVERSIONARY PROGRAM THAT INFORMS STUDENTS ABOUT ALL ASPECTS OF THEIR TOBACCO USE AND TEACHES THEM HOW TO QUIT. STUDENTS ARE REFERRED TO THE PROGRAM BY SCHOOL PERSONNEL, DISTRICT JUDGES, OR PARENTS. SMOKELESS SATURDAY SERVED 807 (1013 REFERRED) STUDENTS IN THE 2023-24 SCHOOL YEAR. SMOKE FREE FOR LIFE IS AN EIGHT-CHAPTER ADULT CESSATION PROGRAM THAT CAN BE HELD IN THE COMMUNITY OR WORKPLACE. IT ADDRESSES EVERY ASPECT OF TOBACCO USE AND TEACHES PARTICIPANTS HOW TO QUIT AND REMAIN TOBACCO FREE FOR A LIFETIME. 34 FACILITATORS WERE TRAINED TO CONDUCT SMOKE FREE FOR LIFE CLASSES, WHILE APPROXIMATELY 1000 PARTICIPANTS WENT THROUGH THE SMOKE FREE FOR LIFE CESSATION PROGRAM IN THE 2023-24 FISCAL YEAR. THROUGH GENERAL COMMUNITY OUTREACH EVENTS, CESSATION SERVICES WERE MADE AVAILABLE TO MORE THAN 3200 WESTERN PENNSYLVANIANS.
