RAHABS SISTERS SERVES WOMEN, TRANS AND NONBINARY PEOPLE MARGINALIZED BY POVERTY, HOUSELESSNESS, SEX WORK, VIOLENCE AND SEX WORK THROUGH A HOLISTIC, GUEST-CENTERED, AND LOW-BARRIER APPROACH OF BUILDING COMMUNITY WITH RADICAL HOSPITALITY. 2024 SAW AN INCREASED NEED IN HOUSING PLACEMENT AND ON-GOING EVICTION PREVENTION SUPPORT, AND INCREASED FOOD ACCESS NEEDS. 6,518 MEALS WERE SERVED TO 1,470 UNIQUE INDIVIDUALS WITH 1,848 FREE SHOPPING EXPERIENCES FOR CLOTHING, HYGIENE AND BASIC SUPPLIES. THE COMMUNITY HEALTH TEAM PROVIDED 656 HOURS OF DIRECT, ONE-ON-ONE SUPPORT WITH ADDITIONAL 1,312 HOURS OF INDIRECT SUPPORT. AT LEAST 19 HOUSEHOLDS WERE PREVENTED FROM BEING EVICTED, AND AT LEAST TWO WERE NEWLY PLACED IN HOUSING.
