CLRJ HAS THREE MAIN PROGRAMMATIC AREAS, COMMUNITY ORGANIZING AND ENGAGEMENT, POLICY, AND RESEARCH. OUR OPERATIONS IN THESE AREAS ARE DESIGNED AS STRATEGIES TO ACHIEVE ANNUAL OBJECTIVES AND LONG-TERM GOALS.COMMUNITY ORGANIZING AND ENGAGEMENT (COE):CLRJ'S COMMUNITY ORGANIZING AND ENGAGEMENT DEPARTMENT AIMS TO BUILD LATINA/E LEADERSHIP AND ENSURE THAT POLICY PRIORITIES ARE INFORMED, SHAPED AND MOVED BY OUR COMMUNITIES. THIS PROGRAM INCLUDED ACTIVITIES THROUGH THE COMMUNITY ORGANIZING PILOT, UNIN DE VECINAS (UDV) AND THE JUSTICE FOR YOUNG FAMILIES INITIATIVE (J4YF). UDV FOCUSED ITS WORK ON TENANTS' RIGHTS AND AN ONGOING HOUSING JUSTICE CAMPAIGN, WHILE J4YF IS AN INITIATIVE OF CALIFORNIA LATINAS FOR REPRODUCTIVE JUSTICE THAT CHAMPIONS YOUNG PEOPLE'S RIGHTS TO SELF-DETERMINATION AND BODILY AUTONOMY, INCLUDING DECISIONS ABOUT WHETHER OR NOT TO BECOME PARENTS, AND THEIR RIGHT TO PARENT THE CHILDREN THEY HAVE WITHIN A SUPPORTIVE ENVIRONMENT. ACCOMPLISHMENTS:- COMMUNITY ORGANIZING AND ENGAGEMENT DEPARTMENT CONTINUED TO DEFEND HOUSING PROTECTIONS AS AN ONGOING COMMITMENT TO HOUSING IS REPRODUCTIVE JUSTICE. CLRJ MOBILIZED WITH THE HOUSING BASE, UNION DE VECINAS, AND OTHER KEY ALLIES TO SAFEGUARD THE RENT STABILIZATION ORDINANCE (RSO) IN BELL GARDENS, CA. THROUGH EXTENSIVE OUTREACH, A SOCIAL MEDIA TOOLKIT, AND BASE BUILDING, WE SECURED 30 PUBLIC COMMENTS IN SUPPORT OF THE ORDINANCE TO ENSURE THE CITY COUNCIL UPHELD THE ORDINANCE DESPITE HEAVY PRESSURE FROM OPPOSITION TO REVOKE IT. CLRJ DEEPENED COMMUNITY KNOWLEDGE THROUGH CIVIC ENGAGEMENT WORKSHOPS, PARTNERED WITH LEGAL EXPERTS (LAFILA), AND SUPPORTED T.U.R.N'S UTILITY CAMPAIGN TO FIGHT UNJUST ELECTRICITY HIKES. CLRJ WAS HONORED AT T.U.R.N'S 50TH ANNIVERSARY TO RECEIVE THE AFFORDABLE HOUSING GRASSROOTS CHAMPION AWARD.- CLRJ'S COMMUNITY ORGANIZING TEAM CONTINUED COALITION BUILDING THROUGH THE INVOLVEMENT IN THE SOUTHEAST LA YOUTH ORGANIZING NETWORK (SYON). AS A COALITION MEMBER FOR THE S.Y.O.N NETWORK, CLRJ DEVELOPED AND DISSEMINATED SURVEYS IN THE COMMUNITY OF SOUTHEAST LOS ANGELES, TOTALING OVER 150 COMPLETED SURVEYS. CLRJ HOSTED A YOUTH VISIONING WORKSHOP WITH THEIR HOUSING BASE TO HEAR THE DIRECT NEEDS OF YOUTH IN SELA.- THE COMMUNITY ORGANIZING TEAM LAUNCHED ITS FIRST REPRODUCTIVE JUSTICE BASE IN SOUTHEAST LOS ANGELES IN MARCH.
