Three of the older children now live at the Zorokoro Children's Complex and attend high school and one older teen is in plumbing school and lives with a supporter of ACFA. ACFA's 25 younger children ages 5-9 live at the ACFA Zorokoro Children's Complex and attend the ACFA school with children from the surrounding villages in kindergarten and first through third grade. ACFA feeds all the children in its care as well as provides meals to the student attending the ACFA school and basic healthcare. The community library and computer lab opened in May 2024.
