We connect leaders in the community, government, and nonprofit sectors. Our networks provide support locally, nationally, and internationally. We build on work happening in local communities by providing tested methods and approaches for inclusive and welcoming places. And we help communities create policies and practices, reinforce welcoming principles, and communicate the benefits of inclusion. In 2024, Welcoming America grew the Welcoming Network to 296 members. Over 650 communities across 7 countries were connected through the Welcoming International Alliance. We reached 26 Certified Welcoming communities, and touched over 5,000 participants with training and coaching on areas such as rural inclusion and community resilience. Over 2,000 Welcoming Week events in 8 countries fostered belonging worldwide.
