Through a large coalition ACCE Action members organized tenants and successfully lobbied legislators to pass Senate Bill 567 which extended tenant eviction protections to renters statewide. A highlight of this effort was the 800-person Housing is a Human Right Capitol lobby and action day in late April organized by the statewide Housing Now! Coalition where ACCE turned out nearly 400 people!
