Critical Home Repair & Neighborhood Revitalization: This program provides critical home repairs and accessibility modifications to help low-income homeowners live in safe and healthy homes. RTGC repaired 45 homes, addressing safety hazards and essential repairs such as roofing, HVAC systems, plumbing, and accessibility improvements like ramps and grab bars. In addition to individual home repairs, RTGC worked on neighborhood revitalization through collaborative partnerships and neighborhood improvement projects, including community beautification efforts and enhancements to shared spaces. RTGC also expanded its service area to include five counties: Mecklenburg, Cabarrus, Iredell, Gaston, and Union, increasing its impact and ability to serve more families and communities in need.

Workforce Development: RTGC supports workforce development by providing hands-on training and career opportunities in the construction trades. In the current year, RTGC trained seven full-time apprentices in partnership with local workforce development training organizations. This program equips participants with valuable skills and certifications, preparing them for long-term careers in the trades. Three of the trained apprentices were hired and promoted to Construction Assistants within RTGC, demonstrating the program's success in fostering professional growth and addressing the skilled labor shortage in the construction industry.
