IN THE PAST YEAR, THE CHARITABLE FOUNDATION OF THE ISLANDS (CFI) EXPANDED ITS IMPACT BY ADDRESSING URGENT POST-HURRICANE RECOVERY NEEDS WHILE CONTINUING TO STRENGTHEN CORE PROGRAMS IN PHILANTHROPY, NONPROFIT CAPACITY, AND COMMUNITY LEADERSHIP. A MAJOR HIGHLIGHT WAS THE LAUNCH OF AN ECONOMIC REVITALIZATION STRATEGY TO SUPPORT LOCAL BUSINESSES, INCLUDING A 100,000 GRANT TO THE SANCAP CHAMBER THAT CATALYZED 1.9 MILLION IN HOSPITALITY RELIEF FOR ISLAND BUSINESSES. CFI ALSO ESTABLISHED A BOARD-LED ECONOMIC REVITALIZATION COMMITTEE AND DEVELOPED THE ACCELERATE LOAN PROGRAM, BACKED BY 1.1 MILLION IN PRIVATE CAPITAL FROM CFI BOARD MEMBERS. SIMULTANEOUSLY, THE FOUNDATION DEEPEDED ITS WORK IN NONPROFIT ENGAGEMENT-HOSTING MONTHLY COLLABORATION MEETINGS, GUIDING CAPITAL CAMPAIGNS, AND LAUNCHING A GRANT WRITING ACADEMY THAT SERVED OVER 30 STAFF FROM 13 ORGANIZATIONS. CFI'S LEADERSHIP SANIBEL-CAPTIVA PROGRAM COMPLETED ITS THIRD YEAR WITH HIGH PARTICIPANT SATISFACTION AND MEASURABLE ALUMNI ENGAGEMENT IN CIVIC LIFE. DONOR SUPPORT WAS SUSTAINED THROUGH ENHANCED STEWARDSHIP EFFORTS SUCH AS THE FRANCIS BAILEY SOCIETY AND A DONOR RECOGNITION EVENT. IMPROVEMENTS TO DONOR-ADVISED FUND (DAF) ADMINISTRATION INCREASED TRANSPARENCY AND USABILITY, AND CFI SECURED 70,000 IN NEW FUNDING FOR ELDERCARE INITIATIVES, INCLUDING ITS FIRST FIELD-OF-INTEREST FUND. WITH INCREASED COMMUNICATIONS OUTREACH, STRATEGIC GRANTMAKING, AND CONTINUED INVOLVEMENT IN CIVIC AND PHILANTHROPIC LEADERSHIP, CFI WAS HONORED AS THE 2024 ORGANIZATION OF THE YEAR BY THE SANIBEL CAPTIVA CHAMBER OF COMMERCE- RECOGNITION OF ITS ROLE AS A VITAL CONVENER AND CATALYST FOR COMMUNITY PROGRESS.
