THE AVERAGE CHAPTER SERVES ANYWHERE FROM 10 TO 20 STUDENTS (SOME MORE THAN 50), PLUS BIG EVENTS RANGING FROM 2502000, MAKING AN IMPACT ON THE CAMPUS.
